Here's an update on where we are on the review of Precinct 4 and the improper destruction of evidence by a property room deputy:

- · Prosecutors are still required to check with Inger Chandler, Craig Goodhart or me on any Precinct 4 case that occurred prior to April 15, 2016 where property or evidence was submitted in order to determine if the evidence has been destroyed before proceeding.
- · All pending controlled substance cases are being dismissed if the evidence has been destroyed.
 - We have identified approximately 90 felony and misdemeanor controlled substance cases that have now been dismissed.
 - Yesterday, we agreed to join a defense attorney in motions for new trial for his client who had pled guilty to three Precinct 4 felony controlled substances

cases on August 11, 2016 in exchange for a 10 year prison sentence. The motions were granted and the 3 cases have now been dismissed. We have not identified to date any other cases that fall within the window to file a motion for new trial.

- All pending non-controlled substance cases involving evidence that has been destroyed are being reviewed to determine the potential impact the destroyed evidence may have on the case. Additionally, we are in the process of sending disclosures/Brady notice to counsel in each affected case. To date we have identified approximately 25 pending felony and 10 pending misdemeanor defendants. Prosecutions in these cases will either be dismissed or continued as appropriate.
- · We are in the process of identifying *all* **pending** Precinct 4 cases (both controlled substance and non-controlled substance) that were filed prior to April 15, 2016. Upon completion, a generic notice concerning the destruction of evidence will be provided to all defense counsel.
- · Additionally, we are in the process of identifying *all* **disposed** cases that may have been affected going back as far as 2007 and involving more than 25,0000 items of evidence. Once we have identified disposed cases where evidence was improperly destroyed, disclosures will be made to the defendants and their counsel.
