EXHIBIT “A”

Definitions

The term “Document” as used herein shall mean any and all manner of written, typed, printed, reproduced, film, or recorded material, and all photographs, movies, video tapes, pictures, plans, drawings or other representations of any kind or anything pertaining, describing, referring, relating, directly or indirectly in whole or in part, to the subject matter of each request, and the term includes but without limitation, papers, books, journals, ledgers, statements, memoranda, reports, checks, drafts, money orders, invoices, receipts, worksheets, work papers, notes, transcription of notes, letters, correspondence, abstracts, diagrams, plans, blue-prints, pictures, specifications, drawings, films, photographs, graphic representations, diaries, calendars, desk calendars, lists, logs, publications, advertisements, instructions, minutes, orders, messages, resumes, summaries, agreements, contracts, telegrams, telexes, cables, recordings, audio tapes, visual tapes, transcriptions of tapes or recordings, or any other writings, or tangible things in which any writing, typing, printing, photostatic or other forms of communication which are recorded or reproduced, as well as all notations on the foregoing; originals and all other copies not absolutely identical to the originals; and all drafts and notes (whether typed or handwritten or otherwise) made or prepared in connection with such documents, whether used or not.

The term includes,

without limitation, emails, text messages, SMS and MMS messages, instant messages, direct messages, private messages, social media messages, chats, posts, and comments (sent or received), messages through messaging applications (including but not limited to WhatsApp), voicemails, voice messages, voice notes, video messages, recorded telephone calls, recorded video calls. The term also includes any and all attachments, photographs, images, videos, audio recordings, voice recordings, documents, files, links, emojis, stickers, reactions, GIFs, metadata, timestamps, delivery/read receipts, and other text transmitted with, incorporated into, or associated with each communication. The term applies regardless of whether the communication was sent, received, forwarded, deleted, archived, or otherwise stored, and regardless of whether the communication was made through a computer, phone, mobile device, tablet, smartwatch, or other electronic device or other means. The term further includes communications made through any account, username, phone number, email address, profile, or other identifier used by, associated with, or reasonably believed to be used by you.

4. “You” means Michelle Acosta, and her employees, agents, and representatives.

5. The term “Video” shall mean and refer to the video posted on September 4, 2026, titled “Cozy Courthouse” in which You appear.
